

Dear Pensioners,

The bank has directed the APGB Pension Fund Trust to stop the deduction of ad hoc amount of EPS pension (up to Rs. 3,800/- for Regular Pensioners and Rs. 2,999/- for Family Pensioners) and to initiate payment of full pension from the month of September-2023 onwards, for retired employees of the Bank who are currently not receiving pension under EPS 1995 and to pay full pension to employees who are going to retire from 01.09.2023, onwards, without any deductions towards EPS 1995 Pension.

As a result, the APGB Pension Fund Trust has resolved to implement the same, effective from 1st September, 2023.

Before making payment of full pension, the Bank has directed the Trust to confirm with the EPF authorities regarding the non-sanction of EPS-1995 pension and to collect individual claims along with an Undertaking/Indemnity bond from retired and family pensioners.

Furthermore, the Trust has been directed to refund the amount deducted towards EPS-1995 pension to the respective pensioners once the Pension Fund Corpus is received from the EPFO.

Hence, the retired and family pensioners who are currently not receiving pension under EPS 1995, are advised to submit:

- **Annexure-I : Application for sanction of full pension without deducting amount towards EPS-1995 pension from the month of September - 2023 onwards.**
- **Annexure-II : Affidavit cum Indemnity letter to be executed on non-judicial stamp paper worth Rs.100/-**
